OBLIGATIO **NS UNDER** THE TEXAS ESTATES CODE: WARD'S BILL OF RIGHTS

OUTY TO INFORM RELATIVES

- orelatives can opt in <u>or</u> out in writing re notice; as soon as practicable, inform:
- death of Ward + funeral arrangements + admission to hospital for >3 days + change of residence
- •BILL OF RIGHTS FOR WARDS:
- Wards have same rights of any adult except where limited by guardianship
- •GOPs should maximize friend & family visitation where possible
- omaximum self sufficiency, control over life, personal environment
- oNEW RIGHT right to speak with MD privately
- to complain about GOPE to court (living arrangements, retaliation by GOPE, conflicts of interest btw GOPE and service providers)
- ohave court investigator or GAL appointed to investigate complaint
- ouncensored communication/visitation with persons of choosing unless causes substantial harm
- to petition the court and retain counsel restoration, modification, new GOPE
- oinfo for Disability Rights Texas, APS, other resources
- oJBCC contact info and procedure to file complaint v. guardian

GUARDIAN' RELATIONSH IP WITH THE WARD, THE COURT AND WARD'S FAMILY & FRIENDS

OLEGAL OBLIGATIONS TO FAMILY

oSec. 1151.056

- duty to inform certain relatives, including those who have elected in writing to receive info re health and residence per TEC 1151.056(d)
- duty to inform relative <u>can</u> be revoked upon motion to the court for good cause
- oshall inform regarding:
 - odeath of ward
 - o admission to hospital for more than 3 days
 - ofuneral arrangements
 - ochange of residence

RESPONSIBILI TIES FROM DAY ONE

provide all required documents to your Ward ... order appointing, Letters of Guardianship, Bill of Rights, etc.
ask Ward to sign for receipt of documents
use this opportunity to build relationship with your Ward
get list of meds and diagnoses, list of medical providers
get bank statements – determine benefits received
file with ... VA, DFAS, SSA, OPM, TRS, TMRS, pension fund

oget the Ward's mail where possible + change address

 mail is good source of info - insurance, financial accounts, tax info (1099s), Medicaid

oget financial data from bank – statements, signature card or account creation documents ☆ ☆ ☆

determine ownership of real property & personal property
 check deed records in and around Bexar County

INFORMED CONSENT AND

DECISION-MA KING

determine preferred language of Ward
any advanced directives or POAs?
does Ward want to withhold medical records?
talk w Ward about necessary treatments for medical issues
talk w Ward about DNR
talk w family, if necessary, about their feelings on DNR

MANAGING YOUR CASE LOAD & YOUR GUARDIANS HIP FILES

- JBCC requirements re what needs to be present in your file
- o at least 20 documents required in file
- can be electronic or paper but must be immediately accessible

CONFLICTS OF INTEREST

 do not hire friends or family for paid work!!
 make these arm's-length transactions ... CPA, lawncare, housekeeper, caregiver, financial advisors, realtors, residential care home owner, insurance agent
